- (iii) To contest for any of the posts, the life member must have <u>attended at least 3 out of the last 5 AGBMs of the Society</u> (Certificate can be obtained by the H.O. & to be submitted with the application).
- (iv) To contest for any of the Honorary office bearer's posts (President Elect, Secretary General, Vice President & Editor in Chief) the candidate should have <u>served at least 2</u> <u>terms as an Executive Council member and completed one full term as one of the</u> <u>nominated office bearers</u> (joint/assistant secretary, assistant treasurer, associate/assistant editor).
- (v) Any member would be considered to have completed his/her one year term in Executive Council only if he/she attends 3/5 to 4/5 (60% to 80%) of the total EC meetings conducted in that year. <u>Out of the 5 EC meeting in a year, a member must have attended</u> <u>at least one of the two EC meetings conducted outside the conference and convention</u> <u>venues</u>. Any member of the Executive Council (including the office bearers) who is absent for three consecutive EC meetings or more than half of the meetings held during his/her term of the Executive Council shall cease to be a member of the Executive Council. Such a member shall not be eligible for re-election/re-nomination to the Executive in the next term.
