- (i) Professional Indemnity Insurance for the members of ISPPD- It was decided to consult various insurance companies for the group indemnity insurance and if annual premium comes to less than Rs. 1,00,000.00 it shall be considered.
- (ii) **PG Convention in 2024** All the members in principle agreed to hold the convention in Dubai and requested the head office to find out the expenses.
- (iii) Initiating Pedo Chapter- President was in the opinion that in order to avoid the disintegration of the society, the society can initiate the formation of different Pedo Chapters in which the experts from all around the country can be included and they should be requested to conduct the programs under the aegis of ISPPD. The Secretary General informed that soon he will propose the groups on the whattsapp and future course of action will be decided thereafter.
- (iv) Travel Expenses for E.C. Members- Considering the increasing cost of travelling, it was decided that a sum of Rs. 5,000.00 shall be given to all E.C. members once in a year to partially cover the travelling expenses for E.C. meetings. This will only be applicable for out of the venue E.C. meetings (other than conference and convention places).
