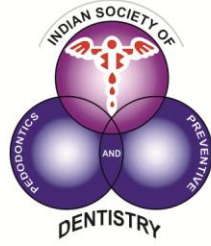

Minutes of the A.G.M. **held on 26.11.2022 at Bhopal**

Agenda -1 Confirmation of the AGM held on 26.11.2021 at Bhubaneshwar/online mode.

The minutes of the AGM were circulated to all members in advance and no comments had been received and therefore considered as passed, proposed by Dr. Virinder Goyal and seconded by Dr. N. Sivakumar.

Agenda -2 Adoption of Annual (Secretary General's) Report:

The Secretary General presented the detailed Annual Report of the society through PPT highlighting the membership growth, 5 EC meetings, various academic activities, publications, social activities and ISPPD awards (2022). He informed that the current membership of the society is 2069 life members and 3008 student members. There were 5 meetings held including one in AIIMS, New Delhi on 13.02.2022 and another on 14.08.2022 at Kolkata. He also informed that several academic activities conducted by ISPPD/in association with ISPPD which included Rapid Division Submit, Reviewer's training Workshop, Faculty Development Program, Certificate Course on Special Health Care Needs in Dentistry along with 3 CDEs.

Secretary General also informed that apart from 3 issues each of JISPPD and news letter Smile Times -Pedo, the society also published a guidelines for ethics in Pediatric Dentistry & Infant Oral Health.

Four social activities were also conducted in the year which included World Oral Health Day, Teacher's Day celebration contest, Children's Day celebration contest, Distinguished Women award.

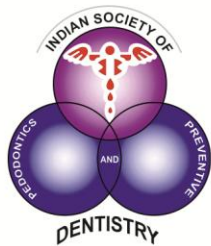

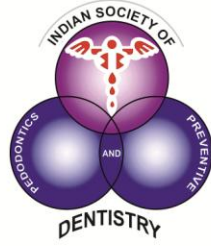

Agenda -4 Adoption of Editor's Report:

Dr. Sharath Asokan, Editor of the JISPPD presented a brief annual report of journal office and informed that the MOU between ISPPD and Wolter Kluwer has been renewed for next 5 years. 3 issues of ISPPD have been prepared in time. The review process is also in time and the grievances of the members are being regularly heard and resolved.

He also informed that some of Rs. 1620981 have been transferred from Axis bank Wardha to the newly opened Journal account in PNB, Tamil Nadu.

Dr. Sharath Asokan informed that Reviewer's training Workshop was organized on 15th- 16th October 2022 at KSR Institute of Dental Sciences and Research, Tiruchengode (TN) attended by 60 participants across the country. He proposed eligibility criteria for editorial team as follows.

- (i) Minimum 10 years of teaching/clinical/research experiences.
- (ii) Minimum 5 articles published in Peer Review Journals.
- (iii) Must be willing of spare times to do scientific reviews.
- (iv) Dr. Sharath Asokan discussed future plans which included increase articles per issue and more issues if possible and efforts to increase quality of JISPPD. The report was passed, proposed by Dr. I.K. Pandit and seconded by Dr. SonaliSaha & Dr. Pooja.

Agenda -5 Adoption of amendments in Society's Bylaws:

Following amendments were proposed in the Bylaws and passed by the house-

- (i) The word "Clinician" will be added along with teacher in the life time achievement award.
- (ii) Article V - Record of the society will be maintained in hard copy and soft copy both the cloud space can be purchased if required.
- (iii) Nominating post in EC should be reviewed every year and depending to the performance, it can be changed in between.
- (iv) In case of an additional EC members, the addition will be done from Jr most to Sr most category i.e. from 8-12 years category.
- (v) Election for the post of VP: The criteria will be modified as follows- He/she should have been completed 3 terms as EC member or have been served for 2 terms as EC member + completed it full term on a nominated posts.
- (vi) B.R. Vacher Oration award- the members of ISPPD of good standing with at least 20 years of continuous membership & name will be recommended by EC.

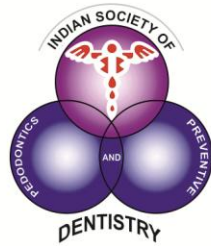

Agenda -11 Any other agenda:

- (i) Dr. Deepesh Prajapati requested to initiate some award for practitioners & suggested that there should be separate category for clinicians for all competitions of ISPPD. It was also suggested that the award should be given at 2 levels. Jr and another Sr. level. It was deferred for the forthcoming EC meeting.
- (ii) Secretary General informed that the conversion rate of students to life members is not more than 25%. Suggestions were invited from the members as to how to increase conversion rate? It was proposed to keep same charges for the students(equal to the charges of the life members) and once the student has passed, his student membership may be converted into life membership just by submitting the proof of MDS passing certificate. It was unanimously passed by the house.
- (iii) Dr Shantanu Choudhari proposed that ISPPD should have a Group Insurance Scheme for ISPPD life members, which was seconded by Dr Prasad Musale and Dr. Saravana.
Dr. Mousumi Goswami suggested to form a committee for the proposal of group insurance. Dr. Radhika Muppa assured that the committee will be formed soon. Dr. Yash Bafana suggested that any professional indemnity insurance provider can be contacted for this purpose.

In the end, Secretary General requested the President Dr. Radhika Muppa to adjourn the AGM. She thanked all the members for attending the meeting and declared the meeting was adjourned.
